ALF BARKER CAUSEWAY

At our last council meeting, Council resolved to advertise a proposal to name the causeway section of Preston Beach Road after the late Alf Barker. Alf was the Shire of Waroona's Works Manager/Supervisor for over 30 years and he was involved in a substantial amount of the Shires' past works activities including the construction of the Preston Beach Road causeway in its present state. Following his passing in 2016 the Preston Beach Progress Association and some residents living in Preston Beach considered it would be fitting to install signage adjacent to the causeway to name it in Mr Barkers' memory.

DRAKESBROOK DAYS AND WAROONA YEARS

Council recently adopted policy guidelines for the sale and distribution of a soon to be released third edition of "Drakesbrook Days and Waroona Years" which was originally printed in 1986 with the second edition in the year 2000. Once again this book has been researched and updated by Shire Councillor Laurie Snell. WAROONA INTERAGENCY

There was a great attendance of 25 members, representing a variety of government agencies and health service providers, who provided an insight into their roles and organisations. The representatives from the Department of Commerce opened the meeting with an engaging presentation on the huge variety of services that they offer to the local community. Following this, the group participated in a workshop aimed at improving the interagency meetings, as well as setting goals and objectives for the group and identifying the current high priority issues in the Shire. The group then took the opportunity to network and access support to work towards the common goals of work towards the common goals of delivering community services and addressing issues around community safety and wellbeing. The Waroona Interagency Group now boasts a database of 70 representatives of databăse representatives from 45 stakeholders including local governments, government agencies, health services and health providers.


