Event withdrawal surprise

The Shire was surprised to receive a letter from Co-ordinator Events Assist advising that it would no longer be hosting the car shows in Waroona that have featured in the Waroona events calendar since 2006. The letter was received the day after the October Car Show where Shire Staff had been involved in the preparation for the day including working with Event Assist on the day to assist the event running smoothly.

The Shire and local

community has given great support to the car shows that have been held each April and October since 2006 with community groups assisting with catering and the Shire providing a great deal of behindthe-scenes assistance including free use of the showgrounds and all facilities, provision of extra bins and toilets where required, cleaners, temporary fencing and sandbags as well as considerable assistance being provided by the Visitor Centre staff. The estimated in-

kind and dollar cost to the Council since 2006 would be in excess of \$30,000.

Events Assist previously been awarded a \$750 grant from the Shire to run a series of workshops and was also selected for a community event award at the 2009 Shire of Waroona Premier's Australia Day Awards.

The car show was originally brought to Waroona in 2006 after being held in Yarloop for a number of years prior.

Admin building roof replacement

Replacement of the roof and rendering of the old section of the Admin building is underway. Preliminary work started with removal of the rear carports and front


flowerbeds. Contractors removed the clay title roof and replaced with colourbond to compliment the recent addition to the building.

In accordance with section 58 of the Land Administration Act 1997, the Shire of Waroona wishes to notify the intention to permanently close a section of Coronation Road located approximately 1km west of the Somers Road intersection, Waroona.



Following road works undertaken during 2008, the Shire of Waroona proposes to amend the road reserve to reflect the new alignment of Coronation Road.

Sea to Art a huge success

The 2011 Sea to ART exhibition at the Waroona Visitor Centre was once again a highly successful event. Featuring 36 local artists including 16 new artists and over 115 pieces of work, the exhibition ran from the 21st to the 31st October. The range of works included paintings, sculptures, pottery, fine woodwork, glass, mixed media and textiles. Taking pride of place at the exhibition was a painting by Cynthia Hauman of newly retired Shire President Mike Walmsley. The Sea to ART exhibition is now in its fourth year and has become an annual event on the Shire of Waroona

events calendar. The exhibition talented Waroona and district artists and their work over a ten day period and this year the standard of works was outstanding. More than 100 people attended the opening night to meet the artists and view the art works. Cr Noel Dew officially opened the exhibition and stated that "the artists, the Waroona Visitor Centre and all who are involved in the exhibition are to be commended on the quality and professionalism of the event." Cr Dew also mentioned the range of talent and styles with the youngest artist being




