Shire President's Message

Community Open Day

On Saturday 10th March approximately 130 people attended a Community Open Day held at Preston Beach. This open day was hosted by the Shire in conjunction with the Preston Beach Joint Venture Group to provide current information and the opportunity to provide community feedback on the development of the townsite structure plan for Preston Beach. Many local landowners and residents, Councillors and Staff from the Waroona Shire also took the opportunity to attend this information session. The next community open day is a Community Workshop scheduled for 19th May, again to be held at Preston Beach. Thanks to the Preston Beach Progress Association who assisted by providing catering on the day.

Community Strategic Plan

This is now in its final stages with a draft plan presented to the Shire by the consultants, SDF Global. The contents of this draft are now being considered by councillors and staff.

Change to speed limit

The current speed zoning on Nanga Brook Road has been a concern for many years with speeding being a major problem despite the fact this road being well signed with the appropriate yellow advisory speed signage. Following a meeting with the Waroona Roadwise Committee the MRWA members of this group investigated the issue and subsequently put a proposal to the Shire to reduce the speed limit from unrestricted 100kph to 90kph. Local police have reported that speeding on this road is a problem and the reduction proposed is strongly supported by

the Waroona Roadwise Committee. The Shire recognises that, whilst this new limit will result in slightly longer travel times for regular users, the end result should be a safer environment for all who use this road.

Review of Local Laws

The Shire will soon advise its intention to review our Local Laws. There are many aspects to our local laws that will be highlighted in the relevant advertising process and I would encourage any ratepayer who may have any concerns with our local laws to make comment during the public submission period.

Policy for Holiday Homes

As a result of the increasing market demand for holiday homes within the Shire of Waroona, especially in Preston Beach, we believe it is important that we consider a Local Planning Policy to guide the development of these holiday homes. For many years now this form of tourism development has meant that holiday homes have been able to operate with minimal regulations, often with a detrimental impact on neighbouring residents. The proposed policy will encourage holiday home operators to abide by recognised practices and not compromise the amenity of nearby residents. Holiday homes are an important part of our tourism industry and as such are encouraged, provided they are well regulated and suitably located. The Shire will be calling for public submissions and once again residents are invited to participate in this process.

School Holidays

We remind everyone taking to the roads to exercise lots of care and caution when driving during this particular busy time of the year. A common-sense approach to our driving habits will go a long way to ensuring you and your family will have a safe and enjoyable journey. Plan your trip and give yourself plenty of time. New Building Act now in force

The new Building Act 2011 started Monday 2 April 2012 and for most people not much will change. There are new forms to fill out for Building Permits (previously called building licenses) applications and Demolition Permits (previously demolition licenses).

The new Act is designed to speed up the issuing of a Building Permit for project home builders and for commercial Building Projects by allowing a building permit application to be 'Certified' by an 'Independent Building Surveyor' before the permit is issued.

As part of the process to speed up building approval times all other approvals, such as Town Planning approval, septic tank approval etc, must be received before the application for a building permit can be submitted to the local Shire.

The Shire of Waroona can act as the Certifier as well as the Permit Authority for all residential building projects like sheds and patios. This is called an uncertified application.

The Shire of Waroona advises anyone considering erecting a building on their property to contact the Shire and speak to a Town Planner and Building Surveyor. They can give advice on what applications and forms that will be needed to allow for a smooth process to obtain the correct permits. This will allow the building to be built as quickly as possible.

Community Considers Preston Beach's Future

More than 130 residents and landowners of Preston Beach and a few from Waroona and Harvey Waroona and Harvey attended the Community Open Day held on the 10 March at the Preston Beach Community The community Centre. had turned out to grapple with the future planning for Preston Beach. The Shire commenced the development of the Preston Beach Townsite Strategy in 2006, the purpose of the Open Day was to re-engage with the community and provide information on the draft strategy which is aimed completion by mid 2012.

Shire President Noel Dew who attended the Open Day said "we have been working on this for a long time now and there are a variety of views in the community. Preston Beach is a wonderful place nestled between the coast and the lakes; it is the Shire's only coastal town and is a valuable for the people of asset the Shire and the region. If development is to go ahead, the challenge is getting the balance right, growing the town to provide the services and facilities people need whilst preserving the things that make it special the unique environment and the coastal village lifestyle".

There has been years of discussion about the future development of Preston

Beach. How big should the town be and what form should it take? Both the Shire of Waroona's Local Planning Strategy and the WAPC policy of 2008 have left the questions to be answered by the Preston Beach Townsite Strategy.

Acuitus and team of planning and environmental consultants also in attendance at the Open Day and were keen to explain their role in development of the Townsite Strategy. "We are pleased to be able to support the Shire in developing the Strategy" said Anthony Rowbottam, Director Acuitus. "We need to know what can be achieved here at Preston Beach and our planning, technical and environmental studies will help us and also inform the development of the Townsite Strategy'

"We, like the Shire are to hear what is keen important to people and what they need. are aware that there are some people that want development and others that do not. Older people and younger families are telling us they need to leave town to be closer to health or education services, and there are also issues with water quality. Also, we understand that people want a caravan park and new community hall" he said.

"The Townsite Strategy is an important first step in planning for the future" said Mr Rowbottam. "It will bring the certainty about the future of Preston Beach that the town community and landowners need setting the broad vision for the whole town and surrounds.

Townsite Strategy the is agreed, we will be able to seek approvals from the WAPC, EPA Commonwealth and Department Environment for staged development" he said.

The Shire of Waroona Joins KidSport!

The Shire of Waroona is pleased to announce that it has received funding from the Department of Sport and Recreation to administer KidSport.

This program provides an opportunity for children to participate in community sport and recreation. Clubs must first register with the Shire of Waroona which then allows children to redeem vouchers with their chosen club for the nominated season. These vouchers are then reimbursed by the Shire of Waroona through the KidSport funding.

Eliqible families must hold a Health Care or Pension Concession Card. Exceptions do apply and registered persons such as teachers, doctors or social workers may also validate vouchers.

What are the eligible criteria?

- · Applicant must be aged 5-18 years.
- · Parent / Guardian must have a Health Care Card or Pension Concession Card or be referred by a 'recognised' referral agent.
- Applicant's primary place of residence must be in the Shire of Waroona (exceptions may apply). It is preferred that applicants register with a club that is in the Shire of Waroona (exceptions may apply).

What else?

- · Funding will cover the cost of fees to join the nominated sport or recreation club (this may include other related costs as identified by the club.)
- Maximum of up to \$200 per child per calendar year.
- · Fees are only for the nominated registered season.
- · No retrospective fees will be paid.
- · No limitation to applications per family as long as criteria is met.
