Review of Local Planning Policy 1 - Community Consultation

The Shire of Waroona is undertaking a review of existing Local Planning Policy 1 - Community Consultation. objective of this Policy is to ensure that an appropriate level of community notification is undertaken to keep any potentially affected party aware of a development proposal or any other matter which may affect them. The policy is drafted to provide apppropriate opportunity to make a submission to allow their concerns to be considered by Council prior to it making a

decision on the subject proposal.

Shire of Waroona
Planning Officers
have cited a number of
operational issues in the
everyday application
of the existing Policy
and this review seeks
to remedy these issues.
Issues identified include:

- Advertising time periods being inconsistent with the Model Scheme Text;
- The inability for the delegated officers to advertise an application for a longer period than 21 days without Council approval;
- Inconsistency with the Shire's Town Planning Scheme; and
- Inconsistency with other Local Planning Policies.

It is considered that the updated Policy will aid the Planning Department

in processing Planning Consent applications faster. The reduced processing time will also benefit applicants.

The draft policy will be advertised for 21 days to allow for submissions. The policy will also be placed on public display at the Shire's Hesse Street Office and Council's website at www.waroona.wa.gov. au. Members of the public are invited to discuss the policy with Planning Services staff and make comment on the draft policy during this advertising period. All submissions received during the advertising period will be considered by the Council.

Submissions on the Policy may be made in writing and should be lodged with the Shire on or before 26 November 2013.

New variable message sign trailer to increase safety

presentation was held at the Shire Depot for the handover of a Variable Message Sign Trailer which was part of a funding application and contributed to by the Shire of Waroona as part of this year's budget.

The key focus of the VMS Trailer is to increase road safety for all road users, the trailer will be used for scheduled road works, events, school zones, and holiday periods. The VMS Trailer can be uploaded with message and images to enhance awareness to the driver that a hazard or event is ahead. The VMS Trailer has been fitted with speed display radar so drivers can be made aware of their speed while approaching roadwork's, this is for both the safety of the driver and the safety of road workers. It is expected that the VMS trailer will be in use with the coming

The funding for the project was provided by the Community Road Safety Grants Program which is funded through speed and red light cameras.

Cat Act takes Full Effect

From 1 November 2013, the full Cat Act 2011 takes effect and will require all cats that have reached 6 months of

- · Microchipped
- · Sterilised: and
- · Registered with the relevant local government,

Cats will be required to wear a collar and registration tag to ensure that owned cats can be easily identified and returned to their owner.

The Shire encourages responsible cat ownership and where possible, keep your cat confined to your property, especially at night.

The legislation requires that a person who chooses to breed cats must apply to their local government for a permit.

When a cat is sold, the seller must ensure the cat is microchipped and sterilised prior to transfer, If the cat cannot be sterilised due to its young age, a voucher must be issued to the new owner.

The Cat Act does not limit the number of cats that can be owned. This will fall to local governments who may have in existence, or choose to introduce

a local law. The Shire of Waroona Health Local Law allows for 2 cats (over the age of 6 months) on any land within the district, Any person seeking to have more than 2 cats will require written approval from Council,

Pensioner and Low Income Earner Discounts and Subsidies

Pensioners will receive discounted registration rates:

Pension card holders are eligible for a discount on cat sterilisation from participating local veterinary clinics and hospitals in the AVA Sterilisation for Cats Program

Pensioners and low income earners (are defined as a person who receives an income of \$37,000 or less per annum. To be eligible applicants will need to provide the Shire with evidence of tax returns and/or tax assessment notices from the Australian Taxation Office or payslips showing the amount of income that they received in the period for which the subsidy is sought) are eligible for a \$50 subsidy from the Shire of Waroona To claim your rebate, cat sterilisation must initially be paid in full, a rebate application form must be completed and submitted to the Shire of Waroona Administration Office, 52 Hesse Street, Waroona, The completed rebate application form must be submitted along with a cat sterilisation receipt from the Veterinary surgeon, evidence of residential status in the Shire of Waroona (forms of residential status evidence listed below) and evidence of your pensioner or low income earning status: Subsidies are limited to two cats per applicant or property.

Recent Changes to the Dog Act

Amendments to the Dog Act and regulations were passed by Parliament on the 24th October 2013. The provisions, together with a new set of regulations come into effect on 1st November 2013

Some of the changes include:

- · All new dogs to be micro chipped
- uniform restrictions

dangerous dogs

• Changes to fees for Dog registration From November 1st 20123, all pups and dogs being registered for the first time will be required to be micro chipped, All other dogs do not need to be micro chipped until 1st November 2015. Other key changes include lifetime registrations for dogs - \$100.00

for a sterilised dog and \$250,00 for an unsterilized dog. Pensioners pay half these amounts. Dangerous dogs must be registered annually.
