- 5. Timber studs can be used in lieu of steel
- 6. Reclaimed timber in / on the big shed has not been specified based on available reclaimed timber from the Shire. Tenders should allow for the builder to supply reclaimed timber for the Big Shed. Reclaimed timber from the Shire to be used for the timber shelter
- 7. We have not noted replacing any timber purlins. The fascia boards are purlins and no allowance for replacement has been specified.
- 8. H3 timber battens to underside of decking will be acceptable in leiu of H4.
- 9. Stainless Benchtop 1.2mm thick 304 stainless steel is acceptable in leiu of 2mm 316 stainless steel. Site joins to be welded (seamless finish).
- 10. Finish to timber shelter to be painted, colours to match old scout hall building shown on the plans.
